Programs Offered

BA LL B 5 Years Integrated Program

Eligibility: 10 +2 with minimum 45% marks for GEN, 42% marks for OBC and 40% marks for SC/ST Candidates.

LL B 3 Years Program

Eligibility: Graduate/ Post Graduate with minimum 45% marks for GEN, 42% marks for OBC & 40% marks for SC/ST Candidates.

Admission Procedure: University Registration / Direct Admission / Through CLAT or HSLT Score.

Scholarship : Scholarship Schemes are made available by the Social Welfare Dept. as per norms laid down by the Govt. of India especially to SC/ST/OBC category of students.

Infrastructure

LIBRARY

HSL Library has adopted an open access system so as to make it easier for the readers to access the library resources thereby saving time. The library has a large collection of Law books, Case Law reports and journals. To assist the students and researchers in locating their desired legal literature and other information, a library automation system has been installed. The Library remains open from 9 am to 7 pm on all working days.

CONFERENCE HALL

We have an air-conditioned conference hall where workshops, seminars and such other program are frequently organized.



HOSTEL

HSL has well furnished separate hostel for Boys & Girls in campus itself with 24 hours power backup facility & attached bathroom.

MEDICAL FACILITY

The HSL has a tie-up with super speciality hospitals. On Campus medical facilities are also available.



COMPUTER LAB

The Institute has a computer lab which is air conditioned and fully equipped with latest configuration. It has more than 200 computers with internet connectivity for the use of the students, teachers and staff working at Harlal School of Law.

CENTRE OF EXCELLENCE

HSL has setup Centre of Excellence to ensure continuous supply of quality training and internship in legal field. These additional training programs are set apart from university syllabus. It has been developed by trainers meant for legal opportunities, including PDP, Drafting skills, Forensic Science, Law & Investigation, Patent law & practice etc. in collaboration with the corporate expertise.

CAFETERIA

A good cafeteria is in the premises itself to provide varieties of snacks, beverages and lunch on subsidized rate.

TRANSPORT FACILITY

HSL Provides transportation facility for students and staff covering almost all the areas of Delhi and nearby locations of Noida.

Teaching Methodology

Harlal School of law offers only professional programs such as BA LLB and LLB . We appoint highly qualified faculty members to enhance the potential of our students and prepare them to face every challenge in the legal professions. HSL has a clearly defined, set mechanism to monitor the learning outcomes. At the beginning of every semester the institute academic calendar containing detail of all the college activities is shared with all the students. Tutorials hours are fixed, Remedial classes are also arranged for the weaker students to improve their academic performance.



Curricular Activities

MOOT COURT

Moot Court Competition is the most effective tool in developing advocacy skills and Court drafts among the students. HSL emphasizes upon such competitions for overall development of students. The HSL Moot Court Society is facilitator of the Moot Court, with eleven regular and co-opted members. Additionally the Moot Court Society is guided by the faculty coordinator and two advisors. The MCS notifies the students of upcoming Moot Court Competitions, Conducts, regulates qualifying rounds and registers the teams with the organizers.



LEGAL AID & LEGAL COUNSELING

Harlal School of Law conducts regular clinical programs. It aims at instilling in the students, a sense of social responsibility and trains them to face various legal challenges. The program includes a wide range of activities like Legal Aid Clinic. Legislative Drafting, Seminars and working on real life Socio Legal Problems. HSL organizes Legal Literacy, Legal Aid Programme, Legal March, Legal Campaign and provides legal solutions to vulnerable & indigent sections of the society. The students also participate in such activities.

Placement

A large number of students are placed in reputed law firms, corporate houses, LPO's & NGO's through Job Quest Expo a Mega Job Fair Organized by Harlal School of Law. The college has also launched a Compulsory Career Guidance Scheme for the IIIrd and Vth year students through which they shall be interned and trained as per the requirement & employability.

Extra-Curricular Activities

The students participate in the annual cultural extravaganza known as "Spriesta". The cultural events include Rangoli Competition, Ad-Mad show, JAM, Group & Solo Instrumental Competition, RJ hunt, Group Dance, Theme Play & Fashion Show. The participants enthrall the audience with their performances. The Annual Sports Meet is organized by HIMT Group of Institutions. HSL students, faculty members and staffs join ardently in events such as Table Tennis, Badminton, Basketball and Volleyball etc. In addition various track and field events are also conducted.
